
CIRCULAR



As of now, approximately 7440 Ha. of land have been registered and provisional notices or notices, as the case may be, for the formation of Consortium have been issued for 15 sectors, out of these, a Consortium has been formed in Sector 8B of Zone P-II under land pooling policy.
